During 2012, Former Executive Director, Dennis Desmaris asked Chairman, Douglas Porter to assist the Center in securing financing for the construction of the new school as well as a source for operating funds, as needed. Douglas was a known member of the Board of Directors of Gulfstream Business Bank(now known as CenterState Bank). Several other options were considered, including the Center's existing relationship with Northern Trust. Based on several factors, the Board decided to secure the financing through Gulfstream. The transactions were fully disclosed to both boards and no conflicts of interest were determined to exist. Mr. Porter was not involved in the evaluation and approval of the loans by either board. As a condition of the above referenced loan, Gulfstream requires the operating accounts of the Center to be maintained at the bank. On February 15, 2014, Gulfstream Business Bank was sold to CenterState Bank, and, as a result, Mr. Porter resigned his seat on the board at Gulfstream Bank.
